## RESOLUTION

Sub: - Absorption of Junior Engineers (Scheme & Estimator) in Odisha Diploma Engineer's Service of Panchayati Raj Department.

The Junior Engineers (Scheme & Estimator) have been engaged under different DRDAs out of the panel list of diploma engineers. Since their engagement, they are working in different Blocks/ DRDAs for proper implementation of various schemes executed at Block/ G.P level. Keeping in view the services they are rendering for the State, their absorption in the existing vacant posts of Junior Engineers under Odisha Diploma Engineer's Service of Panchayati Raj Department was under active consideration of the Government for some time past.

In pursuance of the decision of the Cabinet in its 16<sup>th</sup> meeting held on 13.08.2015 and keeping in view the Resolution No-30500 Dt.26.12.13 of this Department, Government, after careful consideration, have been pleased to decide as follows;

- i) The services of 303 nos. of Junior Engineers (Scheme & Estimator) are here by absorbed against the existing vacant posts of Junior Engineers under Odisha Diploma Engineer's Service of Panchayati Raj Department.
- ii) Their regular services shall be reckoned from the date of their absorption in the Odisha Diploma Engineers' Service Cadre of Panchayati Raj Department.
- iii) On absorption of these Junior Engineers (Scheme & Estimator) in the Odisha Diploma Engineer's Service of Panchayati Raj Department, they will be placed below the existing Junior Engineers of the Cadre.
- iv) The inter-se seniority of these Junior Engineers (Scheme & Estimator) in the cadre shall be decided as per their position in the panel list of diploma engineers.

This has been concurred in by the G.A Department, Law Department and Finance Department vide their UOR NO-495/GAD Dt.22.08.14, No-2054/L Dt.17.09.14 and No-30 SSII Dt.16.02.15 respectively.
