#### RESOLUTION

No. FE-II-AE-(C)-16/2013 96 60 //Dated... 7/3/13

Sub:- Restructuring the Cadre of Odisha Engineering Service and Diploma **Engineering Service.** 

Keeping in view of the workload in various Engineering Departments and to attract meritorious candidates to Odisha Engineering Service and Odisha Diploma Engineering Service Government have been contemplating for restructuring of Odisha Engineering Service and Odisha Diploma Engineering Service.

In pursuance to the decision of the Cabinet in its 46<sup>th</sup> meeting held on 27.02.2009 and in continuation of this Department Resolution No.30828 dated 22.12.2011, Government, after careful consideration, have been pleased to decide as follows:-

"The entry level post of the cadre of Odisha Engineering service shall be at the level of Assistant Executive Engineer in Junior Class-I Branch in the Scale of Pay PB -3, Rs.15,600 - 39,100/- with Grade Pay of Rs.5,400/-.

It has been further decided that a new post of Deputy Executive Engineer will be introduced in between the post of Assistant Executive Engineer and Executive Engineer in the Scale of Pay PB -3, Rs. 15, 600 - 39, 100/- with Grade Pay of Rs. 5, 400/-".

In pursuance of the decision of the cabinet in its 26<sup>th</sup> meeting held on 23.11.2012, Government after careful consideration have been pleased to decide as follows:-

"The entry level post of the cadre of Odisha Diploma Engineering Service shall be Junior Engineer in the Class-III with scale of pay of PB-2, Rs.9,300 -34,800/- with Grade Pay of Rs.4,200/- and their appointments shall be made by direct recruitment through competitive examinations.

Further considering the importance of the works at the field level and promotional avenue of Junior Engineers, it is decided that 50% of the cadre strength of Junior Engineers will be upgraded to Assistant Engineers in the scale of pay in PB-2, Rs.9,300-34,800/- with Grade Pay of Rs.4,600/-. However they will continue to work in the Sections as before".

The cadre strength of the restructured grades/ranks of the Odisha Engineering Service and Odisha Diploma Engineering Service of the different cadres from Junior Engineer to Deputy Executive Engineer of the Department of Water Resources will be as follows:-
