No.WR-FEII-POLICY-0001-2014 // 94 _/WR, In exercise of the powers conferred by the proviso to Article 309 of the Constitution of India, the Governor of Odisha is hereby pleased to make the following rules further to amend the Odisha Engineering Service (Methods of Recruitment & Conditions of Service) Rules, 2012, namely:-

- 1. (1) These rules may be called the Odisha Engineering Service (Methods of Recruitment & Conditions of Service) Amendment Rules, 2015.
- (2) They shall come into force on the date of their publication in the Odisha Gazette.
- 2. In the Odisha Engineering Service (Methods of Recruitment & Conditions of Service) Rules, 2012, in rule 6 after the proviso to clause (c) the following proviso shall be added, namely:-

"Provided further that the maximum age limit shall be relaxed to 45 years in respect of the candidates who have entered the Diploma Engineers' Service as Junior Engineers whether promoted to the post of Asst. engineer or not within the prescribed age limit without the qualification prescribed under clause (b) of rule 6 and have subsequently acquired the same while serving as such or have acquired such qualification prier to entering the State Government Service as Junior Engineers subject to availing of not more than 5 chances."
